SUPPLY PASTORS COMPENSATION

Compensation to visiting pastors is the responsibility of the host congregation

Congregations should consider the following to be a guideline in compensating supply pastors:

- **Supply pastors should be paid on the day they provide the service**
- **One Service of Worship \$225**
- **Two Services of Worship (same day) \$275**
- **Preparing for and Teaching Bible Class/Adult Forum \$110**
- **Mileage should be reimbursed at the standard mileage rate allowed by the IRS of \$.56 cents per mile.**

Example: A supply pastor serving at a Saturday evening worship service and two Sunday morning worship services should receive \$225 + \$275 = \$500 + travel.
